

RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND ASSUMPTION OF RISKS AGREEMENT

FOR GUIDED HORSE RENTALS (ages 10+ years), HORSEBACK RIDING LESSONS (ages 7+ years) AND PONY RIDES (ages 1+ years).

THIS DOCUMENT WILL AFFECT YOUR LEGAL RIGHTS AND OUR LIABILITIES. BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY BEFORE SIGNING!

Langley 204 Horseback Riding Inc. and it's directors, officers, employees, volunteers, agents, representatives, regular riders, lessees, and guides, including any person hired as an independent contractor, (collectively, "Langley 204"):

In consideration of Langley 204 agreeing to accept me on their property and the use of one of our rental horses and accessories on or off this property, I the undersigned understands the following:

1. I am aware that horses and the riding of them involves inherent RISKS, DANGERS and HAZARDS, Including but not limited to the following:

- (a) Dangerous and uncontrolled by Langley 204 terrain: Should you choose to enter Campbell Valley Regional Park, a Metro Vancouver controlled Park which provides an equestrian trail for all public horseback riders, hikers, dog walkers, berry pickers, Metro Vancouver vehicles and workers, and wild life, where as this equestrian trail and it's surrounding park area is not always in perfect riding conditions and changes daily because of weather and unforeseen and uncontrollable foot, horse and wildlife traffic. This area is not regularly patrolled and communication is difficult and rescue and medical attention may not be readily available;
- (b) Langley 204 does provide guides to assist, teach or lead you on your rental horse ride. Regular riders, lessees and volunteers make themselves available to you for all new comers to the area or to our establishment. They are not employees or agents and we make no arrangement for them to be there. However our reputation for years of quality horse care and horsemanship has attracted continuous regular riders which are more than happy to have you join them on their ride. The Buddy System is safer in all sports. These wonderful horse people love to share their knowledge and experience and offer themselves as a community buddy or friend and to help keep our horses safe. These volunteers receive no form of payment and are here strictly out of the goodness of their hearts and therefore accept no liability for your safety .

- (c) Langley 204 does not provide insurance for the rental rider and you must arrange for your own riders insurance.
- (d) We recommend proper riding attire, smooth sole boots with a heel, tight jeans, including your own protective helmet. The helmets we offer may not fit properly or work in protecting you, and may not fit your standard of safety, and in use by many riders which we make no claim to being free of disease or lice.
- (e) We recommend that you stay in line and in the order which has been assigned to you, as some horses are more comfortable in front, behind or in the middle, some are lead horses others are followers and you are safer in line then side by side.
- (f) Horses are weight sensitive and may rid themselves of people which are beyond their weight limits.
- (g) As we cannot communicate with horses, nor can we assume how they will react to any and all situations which may come up during your ride, all horses are deemed unpredictable and dangerous.
- (h) Should your horse be too close to another, then either horse may buck, kick causing damage to either horses and their riders. Should you fall off during these events, you may be kicked or stepped on.
- (i) Severe brain damage or spinal cord damage has resulted from the sport of horseback riding. Including phobias and mental health issues from experiences in horseback riding.
- (j) I understand that I may have limitations in knowing all about all horses and that my skills in communication with a horse may not be the same as I have perceived it to be.
- (k) I understand that being on the ground near a horse is extremely dangerous, horses can bite or kick should they be excited or startled by the smallest insignificant incident or difference around them. In mounting a horse the saddle may slip causing you to fall and be stepped on, or kicked.

2. I EXPRESSLY WAIVE ANY AND ALL CLAIMS, that I may have against Langley 204 as a result of any loss or damage to property or personal injury, including death, which I may suffer or be subjected to as a result of my participation in guided horse rentals operated by Langley 204 ARISING OUT OF ANY CAUSE WHATSOEVER, INCLUDING WITHOUT LIMITATION, THE NEGLIGENCE OF Langley 204.

- 3. I ASSUME AND ACCEPT ALL RISKS, DANGERS, AND HAZARDS in connection with being around or riding horses for myself and/or children I am signing for.
- 4. I AGREE THAT THIS RELEASE AND INDEMNITY AGREEMENT shall be EFFECTIVE AND BINDING upon my heirs, next of kin, executors, administrators, and assigns, in the event of death.
- 5. I AGREE TO HOLD HARMLESS AND INDEMNIFY Langley 204 from any and all liabilities for property damage, personal injury or death suffered by myself or a third party as a result of my participation in guided horse rentals operated by Langley 204.
- 6. I AGREE NOT TO MAKE ANY CLAIM or take any proceedings whatsoever against ANY OTHER PERSON WHO MIGHT CLAIM contribution or indemnity AGAINST Langley 204 in respect of matters which are the subject matter of this RELEASE.
- 7. I HAVE READ AND UNDERSTAND THIS RELEASE AND INDEMNITY AGREEMENT prior to signing it and am aware that by signing this document I AM AFFECTING THE LEGAL RIGHTS AND LIABILITIES of myself, my heirs, next of kin, executors, administrators, and assigns, in relation to Langley 204.
- 8. I AM THE LEGAL GUARDIAN FOR THE UNDER AGE RIDER MENTIONED BELOW AND I AM TAKING FULL RESPONSIBILITY ON SIGNING THIS FORM ON THE UNDER AGED RIDER'S BEHALF AND MYSELF and understand that I may be sued by the parents of this individual, should I be making any false claim to guardianship.
